To the Honorable the District Court of the United States for the Eastern District of Pennsylvania:

Seventh. I am not a disbeliever in or opposed to organized government or a member of or affiliated with any organization or body of persons teaching disbelief in or opposed to organized government. I am not a polygamist nor a believer in the practice of polygamy. I am attached to the principles of the Constitution of the United States, and it is my intention to become a citizen of the United States and to renounce absolutely and forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to VICTOR EMANUEL III, KING OF ITALY of whom at this time I am a subject, and it is my intention to reside permanently in the United States.

Eighth. I am able to speak the English language.

Ninth. I have resided continuously in the United States of America for the term of five years at least, immediately preceding the date of this petition, to wit, since the 20 day of Nov, anno Domini 1904, and in the State of Pennsylvania, continuously next preceding the date of this petition, since the 20 day of Nov, anno Domini 1909, being a residence within this State of at least one year next preceding the date of this petition.

Tenth. I have not heretofore made petition for citizenship to any court.
